Health Insurance Buy-In (HIBI) Program - What is it?

»The HIBI program is a voluntary health insurance premium assistance program for qualified Health First Colorado (Colorado's Medicaid program) members.

- HIBI assists Health First Colorado members pay for commercial health insurance when it is available through an employer (or COBRA) *and* is determined to be cost-effective
- HIBI program helps people get insurance or keep commercial health insurance they already have by reimbursing the Health First Colorado member's portion of the cost of the premium
- HIBI sends monthly premium payments to program participants for all or a portion of the cost of their commercial health insurance premium
- The HIBI program is a way for the State of Colorado to save money/taxpayer dollars



HIBI Program - Objectives

»Partner with Health First Colorado (Colorado's Medicaid Program) to:

- Help individuals or families with high health care costs save money
- Offer cost savings to the State of Colorado for Health First Colorado health care claims
- Grow HIBI program in Colorado by increasing awareness of program benefits



HIBI Program Benefits for Families

- HIBI participants receive **monthly payments** for all or a portion of the cost of their commercial health insurance premiums
- Health First Colorado members will continue to receive benefits for as long as they are found categorically eligible
- HIBI program participants benefit from having access to both Health First Colorado and commercial health insurance coverage
- Wider provider network through commercial insurance coverage
- Coverage of medical expenses by commercial insurance **AND** Health First Colorado, including benefits Health First Colorado may not cover

Eligibility for HIBI

- » HIBI program participants must
 - Be enrolled in Health First Colorado, Colorado's Medicaid Program
 - Have access to commercial insurance that covers at least one Health First Colorado member
 - Have a case that is cost-effective



Cost-Effective Determination

- » HIBI eligibility advisors approve an applicant if he/she meets all qualifications
 - Case is determined cost-effective if
 - Insurance premiums are less than medical costs + out-ofpocket costs + administrative costs
 - Insurance premiums tend to be less than medical costs if
 - There are two or more Health First Colorado-eligible members
 - Expensive medical conditions are involved
 - Including asthma, cancer, pregnancy, diabetes, allergies



Applying for HIBI

» Complete an application

• Submit online, by mail, or fax

» Include copy of

- Insurance card—front and back
- Health insurance rate sheet
- Summary of benefits for those with employersponsored insurance
- Paystub or other proof of premium payment



After HIBI Enrollment

- » The HIBI program participant will
 - Provide proof of premium payment least quarterly
 - Notify of changes to insurance policy or plan
 - Notify of changes in employment
 - Receive monthly premium payments via direct deposit (preferred) or check
 - Participate in annual renewal process



Next Steps

- » Apply or Refer likely individuals or families to HIBI for consideration
 - Inform Health First Colorado members about resources available on the HIBI website
 - Distribute HIBI brochures that include an application and contact information

Frequently Asked Questions

1.Do I need to be enrolled in a health insurance policy before applying?

- » No. An applicant must have <u>access</u> to a health insurance policy.
- 2.Once enrolled, do I lose my Health First Colorado benefits?
 - » No. Once enrolled, all Health First Colorado benefits will continue as long as they qualify for Health First Colorado.
- 3. Does my Health First Colorado dependent need to have a catastrophic illness to be eligible for HIBI?
 - » No. Any individual with a <u>medically expensive condition</u> will be considered.
- 4. How will I find out if I have been accepted?
 - » You will receive an acceptance or a denial letter in the mail.
